AFRICOM: 10 YEARS IN THE MAKING AS A MODEL FOR STABILITY ACTIVITIES

The United States has a compelling national security interest in promoting stability in select fragile and conflict-affected states. The complex AFRICOM operating environment requires a U.S. government response coupled with non-governmental and international partners supported by the affected nations to achieve national goals. Numerous reports reveal persistent gaps in several critical areas: civilian capacity; interagency education; planning and collaboration; cross-organizational understanding of roles and responsibilities; unified assessments and shared understanding; adequate statutory authorities; and funding.

Ten years ago, AFRICOM was purposefully designed to enhance interagency collaboration, while ensuring the efficacy of a whole-of-government approach toward addressing complex challenges in Africa. Many African nations present impending conflict environments necessitating P&SO planning strategies and programs.
